Some tabs as well as the tool bar are not accessible by a keyboard.</p> <p><i>For CFTUI:</i> All functions are executable from a keyboard.</p>
(b) Applications shall not disrupt or disable activated features of other products that are identified as accessibility features, where those features are developed and documented according to industry standards. <p>(d) Sufficient information about a user interface element including the identity, operation and state of the element shall be available to Assistive Technology. <p>(e) When bitmap images are used to identify controls, status indicators, or other programmatic elements, the meaning assigned to those images shall be consistent throughout an application's performance.</p>	<p>Supported</p>	
<p>(f) Textual information shall be provided through operating system functions for displaying text. The minimum information that shall be made available is text content, text input caret location, and text attributes.</p>	<p>Supported</p>	

<p>(g) Applications shall not override user selected contrast and color selections and other individual display attributes.</p>	<p>Supported with exceptions</p>	<p><i>For Copilot:</i> Application overrides user selected contrast theme except for the Help. Windows screen magnifier works with the application.</p> <p><i>For CFTUI:</i> Application overrides user selected contrast theme.</p>
<p>(h) When animation is displayed, the information shall be displayable in at least one non-animated presentation mode at the option of the user.</p>	<p>Not applicable</p>
